PARISHIONERS POINTS

a) Members of the Public

- Cricket Club
- a) To note: SNC has approximately £1.5m funding available for 'Parish causes'
- b) Large applications would have to be match funded.
- c) Cricket Club asking for support for an application of £999 from the New Homes Bonus Fund to help fund a new artificial pitch due to the original matting becoming unplayable. The manufacturer has now gone into liquidation & although the Court found in favour of the Cricket Club's claim, there is now a need to fight for compensation. The club was advised to put in a NHB application for £1,000 by the 28th February.

Old Burial Ground Hedge Removal

a) Residents surrounding the area are concerned about the removal of the old Holly hedge stating that the workmen had simply 'ripped out' the hedge leaving the area in a poor state. The Chairman explained that due to the stare of the hedge, it had been a difficult job to undertake & that a new hedge would replace the old one.
