**MINUTES OF PREVIOUS MEETING:** These had been previously circulated & were duly proposed, seconded, and signed by the Chairman as a true record with the following amendments: P.267: to confirm the exact location of the 4 speed indicator signs to be installed

- a) To be wired into PL48 streetlight outside 81 High Street, Astcote.
- b) In the Birds Hill dip with solar panels & fitted to swivel around periodically.
- c) To be wired into PL58 streetlight on Butchers Lane.
- d) On Butchers Lane at the entrance to the Parish driving from Rothersthorpe, fitted with solar panels. P.267: to note that the mowing contract was approved.

### 10 Leys Road

- A previous application for a dwelling on this site was turned down on appeal.
- This application is smaller & the inspector has no objections.

## Valley Fields, Cornhill application:

- Received from Mr. D. Joyce: objections to the Cornhill application & forwarded to all members.
- Clerk has asked the planning case officer, Shamal London, for updated information.
  - a) Red line boundary dispute being investigated.
  - b) Consultation period to be extended for additional consultations (neighbours/consultees)
  - c) Re-notification (21 days) as number reference of application has been changed from Major to Minor.
- To note, there are 12 properties in Cornhill.
- Objections to the application raised by residents:
  - a) Detrimental to neighbouring properties & an eyesore on the landscape.
  - b) Application in the middle of the site & therefore can be seen from several areas.
  - c) Noise, & lighting pollution.
  - d) No facilities on the site.
  - e) Anti-social behaviour concerns.
  - f) Site is close to the Cornhill burial ground.
- As there is to be a new application due to the red line investigation, the Parish Council's response will be made on the new application.

- There are 14 questions to be addressed & answered.
- Would the PC like to see the confines increased.
- Does the PC want or need further large development.

  - b) Cllrs F. Mitton & J. Russell visited householders to discuss cutting back the foliage on their property which is obscuring the streetlight.
- Large tree on grass verge opposite 12 Birds Hill Road has la large branch which is overhanging the road & obscuring a streetlight. The PC has been informed that this tree has a TPO on it. Clerk to make enquiries about cutting the branch back with the WNC tree officer.
- Light by the OBG delay in delivery of new fittings which in turn is holding up work on other lighting.
- Clerk to contact Mrs Frost in The Crescent regarding a light shining in a bedroom window.

## Highways Safety & Improvements – N. Banister

- Letter sent to Andrea Leadsom MP after her visit to the Parish, regarding the speed limit on the A5.
- Some roads have been patched both large & small patches.
- Some drains have collapsed waiting for Anglian water to make good.
- Millfield there is a 26 week wait for patching work to be undertaken.
